General terms and conditions of the price list

Operations in the harbour area of Port of Helsinki Ltd are subject to the harbour regulations of Port of Helsinki Ltd.

All owners, holders, representatives or other parties responsible for the port fees of any goods or ships arriving at or departing the port area of Port of Helsinki Ltd, as well as those who otherwise use the services of Port of Helsinki Ltd, commit to adhering to the price list and is obliged to provide complete invoicing details to the port. A correction fee of €25.00 per corrected invoice will be charged for any incorrect invoicing details provided. If invoicing details are not supplied, the company providing logistics services will be invoiced according to the price list.

The charges in this price list do not include value-added tax (VAT). VAT is added to the prices according to the valid VAT rate, if sales are liable to taxation according to law and/or decisions made by public authorities.

Payments for domestic traffic are charged with the applicable value-added tax rate included.

In case the liability for payment regarding VAT becomes retroactive on account of changes in interpretation, we presume that clients will act in accordance with Section 178 of the Value Added Tax Act.

The payment time for invoices is 14 days.

Penalty interest is calculated in accordance with section 4(1) of the Interest Act.

The collection fee for consumer customers €5.00 and for business customers €12.00.

If there are any differences between Finnish and English Price Lists, please follow the Finnish one.

Cargo charges

General terms

1. A harbour charge for cargo is levied on goods transported by sea via the Port of Helsinki, in accordance with to the price list for cargo traffic.
2. Goods transported through the port by means other than by sea on a ship are subject to a one-time cargo charge in accordance with the tariff table for cargo traffic. The charge shall be paid by the domestic owner, shipping agent, shipping company, or the person in charge of the cargo during the transport unless otherwise agreed.

The person responsible for paying the charge shall provide the Port of Helsinki Ltd with the information required for determining the charge.

3. Goods charges are levied according to gross weight, unless otherwise stipulated.
4. Charges are waived on the following:
 - passenger luggage and vehicles
 - household goods conveyed by vessels in archipelago traffic or goods brought for sale at the market place or in the harbour
 - containers, pallets and similar transport equipment classified as facilities and not as merchandise, excluding empty vehicle units transported in the South Harbour, Katajanokka and West Harbour.

Cargo will be charged for accordance with the general charge if the transported cargo cannot be divided in charge classes in accordance with the price list or if bulk cargo includes cargo in several price classes.

Requests for compensation for any cargo charges must be submitted to the Port of Helsinki Ltd within three months of the end of the calendar year.

Furthermore, the amount of credit for the requested credit period should not be less than 250 euros.

Dangerous Goods Notification

Advance notification of dangerous goods must always be submitted to the Port of Helsinki's dangerous goods notification system. Further information is available on the Port of Helsinki website www.portofhelsinki.fi/en/professionals/information-for-port-users/security/dangerous-goods

An additional fee of €1,000 will be charged for low-risk units that have not been reported to the system, and €3,000 for high-risk units. High-risk units refer to units containing cargo that meets the quantity and IMDG class requirements requiring a pre-notification.

In export traffic, units stored on the fields will be charged for based on the pricing applied to the vessel's Gate in time. In import traffic, the charge will be based on the pricing applied to the vessel's arrival date.

The dimensions applied to storage fees and the charges levied on empty vehicle units in the West Harbour, South Harbour and Katajanokka Harbour.

The payment will be charged with a 20% increase between June 18 - August 11, 2026, and with a 20% discount between January 7 - February 11, 2026, and August 31 - September 16, 2026.

The harbour charge for passengers does not apply to:

1. Lorry and bus drivers.
2. Persons who have boarded the ship in an official role to inspect or supervise the functioning of the ship's equipment.
3. The vessel's crew members or those in a similar role, who are performing their duties (transfer crews).

Vessel Charges

General terms

The Port of Helsinki Ltd will levy a harbour charge in accordance with the price list on any vessel entering the port area of Helsinki.

1. The basis for this charge is the net tonnage of the vessel. The vessel charge is calculated by multiplying the charge by the net tonnage.
2. If the net tonnage changes in port, the charge will be made according to the highest net tonnage.
3. In order to be able to determine the basis for the charge, the captain of the ship or a representative is obliged to make the appropriate notifications for calculation of the charge.
4. No harbour charge will be collected from vessels in distress.
5. Vessels shall be declared to the Port of Helsinki Ltd immediately after arrival and departure, unless otherwise agreed.
6. A separate fee will be charged for the vessels' waste management in accordance with the confirmed vessel waste charges. With regard to maintenance visits, the accrued expenses will be charged, with an added 10% general charge.
7. The vessel type entered in the marine register does not always determine the vessel's harbour charge; instead, the harbour charge is partly based on the type of the vessel, i.e. whether the vessel is carrying mainly cargo or mainly passengers.
8. For unauthorized mooring to the quay, a fee of 1000,00 € and 500,00 € for each day of mooring commencing from the day of mooring will be charged in addition to the vessel fee according to this price list.
9. For ISPS infringements committed by the vessel's personnel, a fee of € 100 will be charged.

The following discounts are granted for vessels: if the of net tonnage charged for freighters of the same shipping or marketing company during the first or second half of a calendar year amounts to

- more than 100,000 nt the discount for the period is 2 per cent
- more than 200,000 nt the discount for the period is 4 per cent
- more than 400,000 nt the discount for the period is 8 per cent
- more than 800,000 nt the discount for the period is 10 per cent

The discount is granted every six months at the end of each period.

Vessel Charges

Vessels carrying mainly passengers

If the figure indicating net tonnage exceeds 25,000 in this payment class, the excess is calculated with a 25% discount, any excess of 35,000 is calculated with a 50% discount and any excess of 50,000 is calculated with a 90% discount.

The charge entitles a vessel to a continuous stay of 24 hours in the harbour area. If the vessel stays in the harbour area continuously for more than 24 hours, a vessel charge will be applied to every 24-hour period following the first period, with a 50% discount. If the vessel visits the harbour area more than once during one day, only one visit will be charged for.

The berth reservations of ships in this payment class that do not maintain scheduled service in accordance with a published timetable for at least three months must be confirmed two months before the start of the cruise season each year. The cruise season is considered to start on 1 April each year. If the berth reservation was made two or more years before the cruise season starting on 1 April, the reservation must be confirmed both nine months and two months before the start of the season. Reservations that are not confirmed or cancelled on time and cases where the vessel does not show up at the reserved time are subject to a cancellation fee. The cancellation fee is 50% of the vessel charge specified in the current price list at the time of the cancellation. No cancellation fee is charged for vessel calls that are not realised due to force majeure (a storm, technical fault, etc.).

Vessels which maintain regular liner traffic according to a published timetable continuously for at least three months charged by hundred (100) net tonnage units.

If additional ISPS fences or other arrangements are required on the quay or outside the quay area, an extra fee of €3,000 will be charged. If a cruise vessel is berthed at the quay or in the quay area at the same time as a warship of a foreign state, a fee of €3,000 will be charged for erecting a separating ISPS fence.

Environmental discount

Liner traffic vessels that have a low environmental impact in port, or that have significantly reduced their environmental impact with development measures, and that fulfill relevant requirements listed below, may be granted a discretionary discount of a maximum of 11% on vessel charges. The discount is granted based on a separate application. The discount can be applied for under the following three categories:

- Low emissions (based on vessel's ESI- or CSI-certificate score).
- Output noise level of less than 105 dB while docked, of vessels in the passenger harbours (based on confirmed and measured output noise levels while docked).
- Investments/innovations that improve in-harbor environmental efficiency, energy efficiency or noise abatement, for example (based on a report on the change with calculations/measurements of its impact).

Vessel waste management charges

Solid waste, oily waste from the engine room and wastewater

The waste management fee includes the direct and indirect costs associated with the receipt, transport and processing of the waste in question.

The minimum fee for each vessel visit is €267.90 and the maximum fee is €4,684.70.

A 30% discount on the vessel fee is granted to vessels that do not produce oily engine room waste.

The minimum fee for each vessel visit is €343.00 and the maximum fee is €6,072.00.

Exempted vessels

Vessels that have been exempted from the mandatory delivery of waste by the Finnish Transport and Communications Agency do not need to pay the waste management fee.

If a vessel exempted from the waste management fee drops off waste at the port, the Port of Helsinki Ltd will levy a waste management fee in accordance with the price list.

Additional fees

Waste water

There is no separate fee for disposing of waste water (domestic sewage) in the port sewer network. If the waste water pumped from a ship is classified as industrial, the charge will be determined separately. The flushing of waste water hose pipes is subject to a charge of four working hours in accordance with the hourly rate list.

Unauthorized connection to the sewage infrastructure will be subject to a charge of € 1,000.00.

Unloading time

Primarily, waste will be collected as soon as the vessel has docked or at a time specified by the crew of the vessel. The fee for vessel waste management includes a loading time of 4 hours. An extra charge of €85.30 per each hour starting will be collected for time that exceeding 4 hours.

Costs resulting from the discharging of waste will be charged based on the type and/or amount of waste discharged:

For the amount of waste exceeding the capacity of the vessel's storage space, for waste classified as hazardous waste or generated in the sulfur oxide scrubber and for the part of the cost that is not covered by the waste management fee. These charges include a processing charge that is 2.5% of the total invoice amount or a minimum of EUR 43.20.

Unauthorized dumping of waste on the quay is subject to a fee of € 500,00, along with the direct and indirect costs of waste reception, transport and disposal.

Vessels using the port's waste reception service must submit an advance notification for waste delivery to port reception facilities in accordance with Annex 2 of the ship waste directive at least 24 hours before arrival at the port.

Mooring and unmooring charges

The regulations of the European Commission's decree ((EU) 2017/352) related to port services will come into force 24 March 2019 and they will change the mooring and unmooring services offered in the ports of Helsinki.

The Port of Helsinki Ltd has transferred its mooring and unmooring service production to its subsidiary (South Finland Port Service Ltd) starting from 1 January 2019.

Charges for water sales

Water sales charges from hydrants in the harbour

The currently valid water consumption charge set by HSY increased by 10% to cover the maintenance costs of the port network. In addition to this, a service fee of €1.72 per m³ will be charged.

Vessels that maintain regular liner traffic may be permitted to take water themselves from port hydrants. Vessels that have been given permission to take water themselves are charged the currently valid water consumption charge set by HSY, increased by 10% to cover the maintenance costs of the port network.

Unauthorized connection to the port water infrastructure is subject to a charge of € 1000,00 plus a water sales charge in accordance with the price list.

Electricity charges

Temporary consumer

A temporary consumer is a client using electricity at a certain site for a maximum time of 30 days at a time.

Electricity charge

Temporary consumers will be charged a fee for electricity sold in accordance with the monthly purchase and transmission price for electricity paid by Port of Helsinki Ltd, with 20% increases.

Connecting charge per time

Other times

If a fitter is called to work outside normal working hours, overtime – less one hour included in the connection charge – according to Hourly Charges (see page 30) is charged. In addition to this, actual travelling expenses will also be charged.

Unauthorized connection to the electricity network is subject to a charge of € 1,000.00 plus the energy charge as set out in the price list.

Long-term consumer

A long-term consumer is a client using electricity at a certain site for a period of at least 30 days at a time.

If no separate agreement on the price of electricity has been made with a long-term consumer, they will be charged a fee for electricity sold in accordance with the monthly purchase and transmission price for electricity paid by Port of Helsinki Ltd, with 5% increases. However, the charge will be at least the aforementioned connection charge.

Security

Security assessments

Based on the Act on the Amendment of the Act on Security Measures for Certain Vessels and Ports Serving Them and the Supervision of Security Measures, port companies are required to carry out security assessments as determined by the authority's decision. The fees for security assessments are charged according to the rates set by the authorities, with an additional handling fee by the Port of Helsinki.
